It is time for you to join **Indiana Free Legal Answers**. Indiana was the second state in the nation, following Tennessee which created the service, to join Free Legal Answers. This website allows low-income Hoosiers to post civil legal questions on the site and registered attorneys to answer them any time, twenty-four hours a day. Hosted by the American Bar Association, volunteer attorneys in Indiana fielded over 1,700 questions last year allowing those residents to obtain answers without adding to the intake systems of our civil legal aid and lawyer referral services. This service is yet another way VLP stretches our volunteer efforts as far as we can to serve the state. It is an easy and convenient way to do some pro bono service when you have a few extra minutes. There is no obligation to take any matter, your identity is not disclosed to the questioner, and you can preview any question before deciding whether to answer.
