Preparing Your Practice for INfile

WHAT ATTORNEYS AND LEGAL STAFF NEED TO KNOW

1 CLE/1 ETHICS

The Indiana Supreme Court is planning a statewide launch of INfile, its new custom e-filing system, in Spring 2026. This CLE is designed to prepare attorneys, paralegals, and legal staff for the transition by outlining what to expect, key changes from the current system, and practical steps to prepare before launch.

Presented in partnership with the Indiana Office of Court Technology, this program will share the latest updates, address common questions, and highlight available resources. The current e-filing system at efile.incourts.gov will remain available until INfile goes live.



How it Works

- **VLP is referred cases from legal aid partners, often cases they do not have the resources to help.**
- **VLP screens matters for financial eligibility and case priorities to serve vulnerable Hoosiers.**
- **Volunteers indicate if they are willing to work the case pro bono. Your time is volunteered; the client is asked to pay unwaivable fees.**
- **Volunteers work the pro bono case like any other case.**
