PRESIDENT'S MESSAGE

Great Pizza, and Great News



Many critics call Chris Bianco the greatest pizza chef in the US due to a combination of technique and superb ingredients. He finds what is around him in his environment – in Phoenix. Yes, arguably the best pizza maker in the US is in Phoenix – not New York, Connecticut, or Chicago – and he sources local ingredients. Chris has a fascinating story, from dropping out of high school in New York as a junior, to the interaction of his asthma and pizza flour being almost the end of him making pies. When he started his shop inside the back corner of a neighborhood grocery store in 1988, he had little idea it would change the pizza world. People started to flock to him.

If you can't tell, I'm obsessed with pizza. I make it, I eat it, I travel to find great pizzaiolos to go and visit, even arranging where I stay for business trips based on unique pizza joints. But, my point here is Chris took the ingredients in his environment around him in Phoenix, of all places, to rise to the top of the pizza making world. His shop, Pizzeria Bianco, is a pizza mecca. Lines start really, really early.

The point here is this.... Ingredients matter, in all respects. From sourcing ingredients for food to finding the right ingredients that make up your law practice. What and who is around you *will* shape how experience things, regardless of the mission – pizza, to practicing law. Might sound a silly analogy, but it is not.

Where you experience our Bar Association, and how you experience our Bar Association matters. Our physical office space is an ingredient on how the Bar Association interacts with you. I think the next ten years will be transformative for us as an organization. New lawyers – 21 of them at our new lawyer event in November – place a unique value on experiential concepts – from working in environments that make them feel more welcomed, even home, to a more casual work place. Younger lawyers, below 40, react to the working environment differently than generations before them. We, as a Bar Association, need to take that to heart. And we have.

After nearly a year of analysis and deliberation, the Evansville Bar Association Board voted unanimously to move our headquarters to 501 Main Street in downtown Evansville. It will be a space that is welcoming, with close proximity to over 70% of our members, many of them walking distance. It will also house vendors and others in our legal community that work with us – we will have hoteling offices, co-working space and conference rooms available for your use.

In the words of our Young Lawyer Committee Chair, the current location has no impact on young lawyers and many do not even know where it is located. Part of that is proximity and part is the way we use the space. We are investing in our future, investing in the next generation of EBA lawyers, and creating a better experience for engaging with your Bar Association. There will be more on this in the coming weeks. But for now, realize a major ingredient in the Bar Association is changing, we believe for the better.

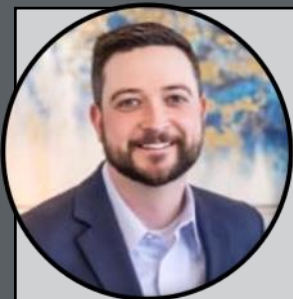
