he EBA has a tradition of sending the incoming President to the ABA's Bar Leadership Institute (BLI) every spring. The BLI is a meeting of executive directors and their incoming presidents from bar associations across the

country. It encompasses associations ranging from small local bars to large state bars and provides workshops aimed at enriching the leader's limited time with his or her association. This year I attending the BLI in Chicago March 17-18. I

walked away with a clearer understanding of what a bar president should be, and I want to start my term by sharing a few of the lessons I learned.

The first lesson I learned is that while the EBA is on the much smaller end of the membership spectrum of attendees, our membership rate is truly outstanding. State and local bar leaders, regardless of the number of members they had, were visibly shocked when I informed them approximately 80 % of the attorneys in our county were members of the EBA. Further, I was able to tell them our membership is trending up, with an all-time high number of over 550 in 2015. These statistics are exceptional and demonstrate our attorneys' involvement in an association they have found, and continue to find, worthwhile and rewarding.

The second lesson is the best bar presidents are emissaries and advocates of their association. The president should represent the sentiment of the association (as a whole) and present that to the public and other legal groups. Perhaps it goes without saying, but I want to be available and open to meeting with you to discuss where our bar is, and where it is going, any time you would like. Please feel free to reach out.

A third lesson I learned focused on new (often young) lawyers. A recent study showed new lawyers have concerns about professional development, love a robust online presence, and want mentoring programs. I was eager to share that the EBA recently overhauled its website and started a Lawyer's Lunch Club that showed great promise (expectations were exceeded when the second round added 30+ participants!). I recall the last time I shared an upcoming Talk to a Lawyer event on Facebook, I had a significant number of non-lawyer friends share and comment on that post. The EBA is working to address the needs of attorneys from all experience levels and I look forward to us continuing this effort.

The final lesson I want to share is what I might describe as "integration." The concept is that a bar association has much more to offer than CLE. The bar association is a meeting spot, a social club, a resource for practice information, a networking center, and much more. An inescapable fact is that the more options you have to be involved, the more likely you are to be involved. I believe we offer a wide range of opportunities to be involved, and our numbers show we are an involved group. Nonetheless, we should always strive to improve and we welcome new ideas to discuss. What would you like the EBA to do?

As I finish this first Summation article, I realize I am at my word limit and left out several more lessons from the BLI. Hopefully you have the sense that I am excited about the upcoming year. More than that, I hope you are excited about the upcoming year. With excitement and anticipation in my heart, I thank you for the opportunity to serve our fantastic association for the next year.


New Membership Committee Forming!




